## **News from ISMS**

We recently received a dose of good news related to ISMS' work in regulatory advocacy. The Centers for Medicare and Medicaid Services (CMS) announced it would "pause" its home health pre-claim review demonstration project. The demonstration project was rooted in a CMS effort to decrease fraud in the home health industry, which accounts for a significant volume of deceptive billing. Unfortunately, the pre-certification protocol placed significant burden on doctors.

Despite plans to launch the project in multiple states using a phased approach, Illinois was the only state where the controversial initiative was actually implemented. In acknowledgement of the program's flawed design, and in response to concerns raised by vocal stakeholders affected by the Illinois launch, CMS has suspended the program while it gathers additional feedback and identifies improvements to be made before restarting the initiative.

CMS's action means the project will be shelved for now while they attempt to develop a less onerous manner for home health oversight.

ISMS' advocacy against the pilot was significant. In addition to outreach to CMS, we also voiced our opposition to the Illinois congressional delegation and issued a "call to action" to our members requesting individual outreach to CMS and Congress. While this type of advocacy affects a select segment of our members, it's a clear win for ISMS and a great example of the unique ways ISMS stands for doctors.

ISMS stands for patients as well. By far our most significant legislative initiative this year is a bill to curtail the insurance industry practice of narrowing networks.

Our best estimates are that more than 300,000 patients have purchased health insurance plans that put them in narrow networks, which cover only a few health care professionals and institutions. Often, they've done their homework and checked that their doctor is in-network. But when they show up to their appointment, it turns out the insurance company website was out-of-date, and they won't get the coverage they were promised.

ISMS is working to pass the Network Adequacy and Transparency Act, a law which would provide significant protections for patients, particularly at a time when many people are concerned about losing their health insurance altogether.

Among other provisions, the NAT Act establishes standards for the ratio of healthcare professionals (including specialists) in the network to the number of insureds; requires health insurers to provide notice to patients when their healthcare professional is no longer in a network, and allows patients to change plans if this occurs; allows patients with serious health conditions or who are pregnant to stay with their healthcare professional if the network changes; and ensures that network directories are accurate and kept up-to-date.

The NAT Act is a true bipartisan effort, and the response has been extremely positive; we have more than fifty sponsors in the House from both sides of the aisle. **This bill is very important to our patients, and as physicians we need to call our legislators and urge them to support it – phone calls from constituents are extremely effective.**
